INFORMATION ON TAX COLLECTION FOR 2021-2022**

Enclosed is your 2021 Property tax bill. Please return the tax bill to the Town Treasurer's office if you are not the owner of the property described on the tax bill.

LOTTERY & GAMING credit <https://www.revenue.wi.gov/Pages/FAQS/slf-lotcr.aspx> If you do not currently have a lottery credit on your tax bill, contact the Town Treasurer. You are eligible for the credit if you lived in your home as your primary residence as of Jan. 1, 2021
First Dollar Credit <https://www.revenue.wi.gov/Pages/FAQS/slf-fdolcred.aspx> Every taxable parcel (business, commercial or private) containing a real property improvement (ex: building) qualifies for the First Dollar Credit. Unlike the Lottery & Gaming Credit, the property does not have to be the owner's primary residence.

**PLEASE USE THE MAIL OR DROP BOX BY TOWN HALL FRONT DOOR FOR
PAYMENT. We will honor the postmark date for mailed payments.**

IF YOU PROVIDE A STAMPED, SELF-ADDRESSED ENVELOPE, YOUR RECEIPT WILL BE RETURNED TO YOU.

Write checks for the exact amount of the Tax Bill. A separate check must be made out for the dog tags. We cannot make change for overpayments. A refund check will be mailed to you after the next Town of Rubicon Board meeting. To avoid waiting for your refund check, request your mortgage company to write the check out for the exact amount on your tax bill. Your tax bill is to be made out to: **TREASURER, TOWN OF RUBICON.**

Real Estate tax payments remain the same, full or first half installment payments are due by January 31st, 2022. **DO NOT PAY THE TOWN TREASURER FOR THE SECOND installment. It is due directly to the DODGE COUNTY TREASURER by July 31st, 2022.**
